POSITION SUMMARY: The Web Developer will provide both backend and frontend development for new and existing websites and applications. This will include writing markup, coding, integration with other systems, testing, quality assurance, and troubleshooting. The Web Developer will also provide maintenance and administration for the sites/applications including maintaining the underlying servers and services on which they run.

- Conduct research into current and emerging web technologies and issues in support of web development efforts.

Operational Management

- Install and configure HTTP servers and associated operating systems.
- Identify, recommend, and prioritize new web features and applications in conjunction with business leaders and department managers.
- Oversee web development projects, including intranets and extranets.
- Develop, code, install, test, debug, and document company web applications and sites.
- Update web pages to ensure site accuracy and currency.
- Diagnose and troubleshoot problems with existing web applications and sites.
- Work with database administrator to design, develop, and update databases as they relate to web applications.
- Ensure security of all websites and related applications.
- Perform periodic website audits.
- Monitor and report on website traffic and performance.
- Help desk tickets support.
